## BU pauses Pride flag removals after protests

### Policy review announced after students and faculty rally over enforcement of signage rules affecting LGBTQ+ displays

Boston University has paused enforcement of a campus signage policy that led to the removal of Pride flags from some offices after protests by students, faculty and staff earlier this month.

University President Melissa Gilliam announced April 6 that the school would temporarily halt enforcement of the rule while administrators review the policy and its

impact on the campus community, according to WBUR.

The controversy centers on a university policy that restricts signs, posters or flags mounted in outward-facing windows or attached to university property. Administrators said the rule is intended to apply to all signage regardless of viewpoint, according to information published by the university about its posted-materials policy.

University officials began asking some offices to remove outward-facing Pride flags in 2025, and the issue intensified during the spring semester when additional flags were taken

## You Can't Talk the Gay Away

On International Transgender Day of Visibility in March, the U.S. Supreme Court ruled that therapists' speech is protected under the First Amendment. In an 8-1 decision in Chiles v. Salazar, a case centered on conversion therapy, religious and conservative groups celebrated the rul-

ing. The plaintiff, Kaley Chiles—an evangelical Christian and licensed therapist—argued that Colorado law violated her free speech rights when working with young people "who have same-sex attractions or gender identity

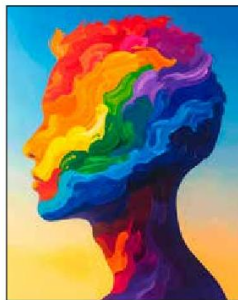

tagon had bitterly lectured the Vatican's ambassador to Washington over Pope Leo's criticisms of Trump's warmongering. His Holiness, a humane and kind man who understands servant leadership better than Trump ever will, was rewarded on April 12 with a direct personal attack by Trump via social media.

Trump, with his utter lack of decency and self-control, thus confirmed once again our well-advanced slide into a post-American world disorder he created thanks to millions of voters refusing to recognize he is not a leader but a saboteur.

It is one thing for a country to grow and develop. It is another to be a changing—to transform into something completely different and contrary to what one previously stood for.

Fundamental freedoms are under assault, including freedom of the press, freedom of religion, the right of the people peaceably to assemble, the right to vote, and due process of law.

The president postponed by two weeks his threat to end an entire civilization, which was as blatant a threat of genocide as one could make without using the word. To completely destroy Iran, including its civilian infrastructure, would be a violation of international law and a betrayal of American values. We cannot accept being turned into such a monster.

Our leaders' willingness to commit and even boast about war crimes invites our adversaries to do the same to our service members.

Generations of Americans have struggled

to make our country live up to its principles, including the promise of "equal justice under law" carved above the entrance to the Supreme Court. These basic values are being dismissed and derided as "wokeness," as if only straight white cisgender men could possibly be qualified for any job.

That assumption flies in the face of a great deal of evidence, including Justice Ketanji Brown Jackson's sharp grilling of counsel during oral arguments, and her written opinions.

Pretending that we can wall out the world only leaves us worse off. Past colonialism and imperial conquest come back to us in the form of migration, while electing a sociopath to lead our country has spread violence across the globe.

We cling to comfortable certitudes and prejudices, and when they leave us worse off, we find other people to blame.

An Afghan-born teen whose father helped American troops in Afghanistan is arrested by Immigration and Customs Enforcement agents. Senator Richard Blumenthal decries this cruelty, and the MAGA response on social media is a false disparaging generalization about immigrants and a claim that our president is protecting America.

This has it backwards. The main criminal endangering our country is the man in the White House. The main terrorists are the ICE agents he is using as secret police.

Israel's insistence on having defensible borders means in practice that it is entitled to expand its borders as its leaders see fit. That sabotages a two-state solution. My support for a state of Israel does not mean a constantly shape-shifting, imperialist one.

The shape-shifter I am most familiar with is the fictional Odo from "Star Trek: Deep Space Nine." He was played by actor René Auberjonois. Odo had been raised by humans, or "solids" as others of his kind called them, and felt a certain attachment to them.

In a 1993 episode, Odo was stuck in an elevator with Betazoid Ambassador Lwaxana Troi, played by actress Majel Barrett. He grew extremely tired, but did not have his bucket to melt into to rest, so the ambassador raised up

her metallic dress and he gratefully melted into that.

It would be a great blessing if our shape-shifting president melted into a bucket. That option being unavailable, we have some serious, old-fashioned political organizing to do to restore and reinforce our democracy.

vey (NSCS), released March 31, asked 2,800 LGBTQ+ students (including intersex, asexual, and two-spirit youth) in U.S. middle and high schools to reflect on the 2023–2024 school year. Glisten also organized focus groups in 2025 with 36 students who were underrepresented in that sample or in national LGBTQ+ research, including Asian, Black, Latine, trans femme, intersex, disabled, and rural students, and ones in Southern states.

Two-thirds of respondents and more than two-thirds of trans and gender-expansive ones felt unsafe at some point due to their LGBTQ+ identity. Just under two-thirds of respondents experienced verbal, physical, or online harassment/assault because of their sexual orientation; and just over two-thirds reported the same due to their gender identity or expression.

Those numbers are not surprising; schools have unfortunately long been hostile climates for LGBTQ+ youth. Under Trump, however, things are getting worse. The NSCS also found that students experienced increased hostility, bullying, and harassment after the 2024 election, and "felt schools were frozen into inaction out of fear of being targeted or losing funding." As one 15-year-old in a rural focus group in Oregon noted, "There are people in high positions of authority...[who] have a lot of say over how young people think. When you hear...them saying some pretty horrible things, it normalizes it."

Glisten emphasized, though, that the students' experiences are "multi-dimensional" and the youth shouldn't simply be categorized by the binary of "victims" or "leaders." It also indicated actions schools can take to support them, including staff training, taking reports of bullying seriously, enacting LGBTQ+-inclusive school curricula, supporting GSAs (gender and sexuality alliances) and other student organizations, and clarifying

and implementing explicitly LGBTQ+-inclusive school policies and practices.

Another recent study, "Impact of the Trump Administration on Transgender Parents and their Children," was released April 9 by the Williams Institute at UCLA School of Law. Abbie Goldberg, professor of psychology at Clark University and Williams Institute affiliated scholar, and Brad Sears, distinguished senior scholar at the Williams Institute, surveyed 108 parents on the topic last year: 37% nonbinary, 32% transgender women, 22% transgender men, and 9% genderqueer, genderfluid, or genderflux. One-third were people of color.

Among the 55% of respondents who felt that their children were old enough to be aware of and impacted by the administration's policies, two-thirds (66%) said their children had increased anxieties and/or fears because of the Trump administration. Over half (56%) said these included new worries or concerns, including ones about their parents' safety and/or lack of access to gender-affirming care; discrimination, harassment, or violence towards their families; and questions about why people don't like their parents or families. One parent observed, "My eldest daughter even at a young age is beginning to ask often more into the subject of 'why people are mean to families like ours.' The changes in language and attitude in media and some public spheres seem to register emotionally with them, even though they may not grasp the politics behind it."

Another parent even shared, "My older child asked whether families like ours would still be allowed to stay together if laws keep changing. My younger one asked if people will always be mean to us for being different."

Goldberg explained in a statement that these fears "strike at the heart of their security and stability. For many, what is at stake is not simply a matter of hardship, but whether their family will survive the Trump presidency intact."

The parents used three key strategies, however, to address children's concerns: acknowledging,

validating, and processing them; providing reassurance that their families were safe; and promising to advocate for them. They also provided information, worked to build their children's self-esteem, cultivated open communication, and shared historical perspectives on what was happening. As one parent explained, "I reassure them that our family is strong, that I will always protect them, and that there are many people and communities fighting for fairness and love—even when it feels like the world is uncertain."

Most of the parents (87%) also took specific steps to protect their children, including limiting their own or their family's visibility in public spaces and/or social media; avoiding one or more family-oriented spaces and events like playgrounds, school events, and birthday parties; moving or considering moving; homeschooling or changing schools; securing legal safeguards to protect their familial relationships; and taking self-defense classes or buying personal safety devices.

One-third of respondents also said that because of the Trump administration, they were planning to have fewer children, while others indicated that the timing or method that they had planned to use to grow or start their families had changed.

Despite the challenges, however, many respondents also expressed strength and resilience. As one said, "I am not stopping myself from living my life because of bigots in this country. My and my family's lives matter too."

Many other groups of children have been negatively impacted by this administration, too, including trans children kept from medically prescribed care and children, particularly those of color, in ICE detention centers. These two studies add to that bigger picture of the damage that is being done to the next generation and offer some important protective suggestions.

confusion” and who seek to “live a life consistent with their faith.”

Conversion therapy—also known as reparative therapy—is rooted in the Christian ex-gay movement that spread rapidly in the 1980s and 1990s before largely fading in the 2000s. However, it resurfaced during Donald Trump’s first term and, in his second, has reemerged more openly and assertively.

This form of psychotherapy, which purports to help LGBTQ+ people become heterosexual, is hardly new—despite overwhelming evidence discrediting it as ineffective pseudoscience. In 1997, the American Psychological Association issued a position statement affirming that “homosexuality per se is a normal and positive variation of human sexual orientation.” In 2021, the APA strengthened its opposition to conversion therapy with new resolutions. Earlier, in 1973, the American Psychiatric Association removed homosexuality from the DSM, declaring it not a mental disorder, and in 2000 formally opposed conversion therapy.

The emotional and psychological harms associated with these programs are profound. They are linked to high rates of depression, anxiety, self-destructive behavior, sexual dysfunction, avoidance of intimacy, loss of faith, suicide, and the deepening of internalized self-hatred, among other damaging outcomes.

Progressive religious groups—both straight and LGBTQ+—have condemned the ruling. As DignityUSA executive director Marianne Duddy-Burke stated in a press release: “Throughout our more than 57 years of ministry, we have worked with hundreds of LGBTQ+ people who have undergone conversion therapy. Every one of them described it as a dehumanizing, horrific experience. Not only was it ineffective at changing their sexual orientation or gender identity, but it resulted in deep shame that many tried to treat

with alcohol, drugs, or even suicide attempts. It took years to recover, in most cases.”

When it became clear that conversion therapies could not “pray the gay away,” and programs like “Jesus Camp” failed to achieve their aims, religion alone became a less effective tool for discrimination against LGBTQ+ Americans. Now, those same efforts are being reframed and protected under the banner of free speech.

The truth remains: conversion therapies have an estimated failure rate of 90 percent. Numerous “ex-gay” organizations have shut down after their leaders publicly acknowledged their own sexual orientation or gender identity. Many prominent figures within the movement have been exposed as fraudulent.

A well-known example is John Paulk, once a nationally recognized “ex-gay” figure. In 2000, he was photographed in a Washington, D.C., gay bar by Wayne Besen of the Human Rights Campaign—an image captioned simply, “Gotcha!” The Kodak moment caused a stir, as Paulk attempted to conceal his identity. His explanation—that he entered only to use the bathroom—was widely questioned, given that he remained there for 40 minutes.

Paulk, a former drag performer known as Candi and a runner-up in the Miss Ingenue pageant, was at the time married to a woman who also identified as a former lesbian through an Exodus International ministry. The couple became high-profile symbols of the ex-gay movement, appearing in 1997 on the cover of Newsweek, as well as on 60 Minutes and Oprah. They co-authored Love Won Out, a memoir that became foundational to Focus on the Family’s ex-gay conferences. Their marriage ended in divorce in 2013—the same year Exodus International closed its doors.

In a public apology, Paulk later renounced the ex-gay movement and expressed remorse for the harm caused. He stated: “I no longer support the ex-gay movement or efforts to attempt to change individuals—especially teens who already feel insecure and alienated. I feel great sorrow over the pain that has been caused... I am working hard to be authentic and genuine in all of my relationships.”

When we fail to recognize that human life is varied, precious, and of equal worth—as conversion therapies do—we deny the unique gifts each person brings to the world. These practices, whether administered by clergy or licensed therapists, do not honor human diversity; they attempt to erase it. In doing so, they diminish not only individuals but also violate fundamental civil rights.

Sadly, with the ruling in Chiles v. Salazar, there is now concern that existing bans on conversion therapy in 27 states could be challenged and potentially overturned.

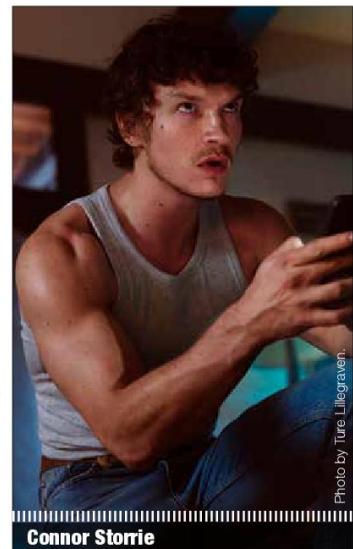

down in campus buildings, according to Boston.com.

The removals prompted criticism from members of the university community who said the policy disproportionately affected LGBTQ+ visibility on campus.

On April 2, students, faculty, alumni and staff gathered outside Boston University's administrative offices to protest

the removals and call for changes to the policy, according to Boston.com. Organizers also circulated a petition seeking to allow Pride flags and similar displays in office windows.

In her message announcing the pause, Gilliam said the university needed more time to evaluate the policy and acknowledged that the controversy had been painful for members of the LGBTQ+ community, WBUR reported.

University officials said discussions about the policy and possible revisions will continue.
